Exit	Dancers, staff	4	1/0.5	4/2	None pre-covid	Exit class observing distancing guidelines, different exit to entrance. No new entries until exiting is complete
Cash Handling	Dancers, staff	4	1/0.5	4/2	Mostly online payments, some self-scan	All self-scan or verbal ID entry, no cash, online payments only, mask on door entry staff if inside 2m, no closer than 1m at desk via barrier
Respiration	Dancers, staff	4	1/0.5	4/2	Opening doors/windows when hot	Open doors and windows as much as possible, encourage distancing in class at 2m and more, maintaining air flow even when colder, face coverings optionally worn

Existing Illness	Dancers, staff	4	1/0.5	4/2	10-day self-isolation from onset of symptoms Swab tests currently ~70% sensitivity	No attendance with symptoms or same household symptoms, regardless of swab test results, until 10 days after symptoms end



New Illness	Dancers, staff	4	1/0.5	4/2	Developing high temperature or persistent dry cough requires self-isolation for 10-days or negative PCR test.	Anyone developing symptoms advised to leave immediately with partner and follow latest government advice. Attendees advised, all evening following classes cancelled, anyone within 2m or closer contact with case advised to self-isolate for 10 days. Cooperation with Track & Trace
Audience	Dancers, staff, audience	4	1/0.5	4/2	Spectators normally not permitted	No spectators, or children, only entry to pre-registered couples for dancing
Untraceable	Dancers	4	1/0.5	4/2	Contact details of attendees held	Ensure current details up to date and full register is accurate
Hygiene	Dances, staff	4	1/0.5	4/2	Regular venue cleaning regimes, hand hygiene	Hand sanitiser on way in, doors propped open, reminding handwashing before attending and when leaving/arriving home. Do not touch faces. Do not touch shoe soles. Hand hygiene from toilets. Signage to effect.

5 - death	5 - certain	8 - 10	Urgent action
